Cases in Point: Example Projects

Our healthcare investigative, litigation support, and compliance services teams have helped hospitals and healthcare organizations across the country address a diverse range of challenges. Some examples include:

- A hospital system received whistleblower allegations concerning one of its physicians' possible fraudulent billing practices. Crowe conducted a detailed investigation analyzing patient electronic medical records and hospital communications. At the conclusion of the investigation, we provided hospital management with conclusive facts to assist them in navigating this sensitive issue.
- A hospital system was faced with a vendor dispute about possible payments
 to a contract physician outside the terms of their agreement. We were able
 to use our forensic accounting and investigative skills to quantify certain
 payments and provided hospital management with a detailed report to help
 them mediate this matter.
- A hospital system was preparing for litigation surrounding allegations of poor performance by the hospital's former revenue cycle management vendor. Using the Crowe proprietary database of healthcare performance indicators, we assisted the hospital and outside counsel by developing a report that quantified the damages related to inadequate services provided by the vendor. During our investigation, we also uncovered electronic evidence through the use of our computer forensic technology that supported their case.
- When a healthcare laboratory had its Medicare billing privileges revoked, we assisted retained counsel by interviewing personnel, observing laboratory operations, and reviewing significant documentation to assess improvements in laboratory operations over several years. The laboratory's legal team was able to use our observations as evidence that billing privileges should be reinstated.
- A hospital was subpoenaed by a grand jury that was investigating allegations
 of the hospital's marketing practices and whether these practices violated
 Stark Law provisions. We collected data, performed mass word searches,
 and identified potentially important documents that outside counsel utilized
 to mediate this matter.
- A health system wanted a comprehensive compliance program assessment.
 We reviewed compliance program-related documents and interviewed board members, leadership, and management. We identified strengths and opportunities for improvement, and recommended process changes that resulted in a more mature compliance program and improved understanding of compliance responsibilities among operational leadership and management.
