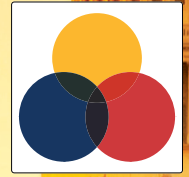


GDPR: Employee Training

How is your organisation responding to Article 39(1b)?

With the 25th May deadline fast approaching, now is the time to also consider Article 39(1b), which holds your organisation accountable for providing data privacy and protection training to employees:

*The data protection officer shall have at least the following tasks: to monitor compliance with this Regulation, with other Union or Member State data protection provisions and with the policies of the controller or processor in relation to the protection of personal data, including the assignment of responsibilities, **awareness-raising and training of staff** involved in processing operations, and the related audits.*

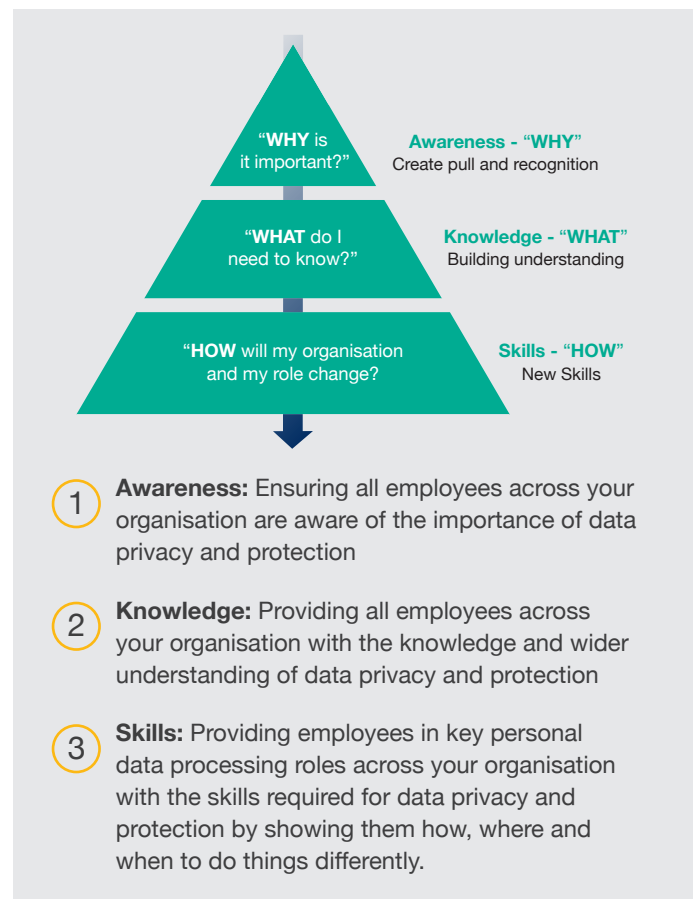
The GDPR mandates the requirement for training because it recognises that compliance can only be achieved and maintained when employees understand how to collect, use and protect personal data appropriately.

Even the best systems, business processes and policies will only achieve a degree of compliance with the new regulation, because without training, employees will be unable to understand how to adopt, apply and adhere to them.

The benefits of training reach further than reducing the risk of a personal data breach, financial penalties and reputational damage. Your organisation can seize the opportunity to instil a data privacy and protection culture, build trust and loyalty with customers and employees, and develop an advantage over competitors.

There are three stages of training that will need to take place:



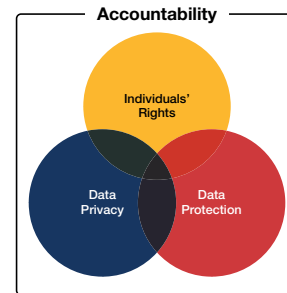

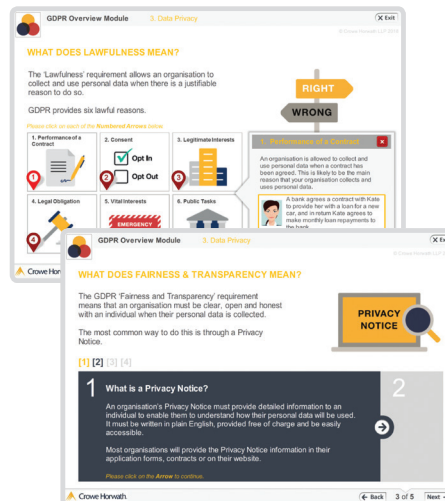
Our GDPR eLearning course has been designed and developed to enable your organisation to successfully deliver the required training:
